WE DELIVERED 940 PROGRAM HOURS FROM COMMUNITY-BASED PROGRAMS, IN PARTNERSHIP WITH SCHOOLS AND YOUTH-SERVING ORGANIZATIONS; AND TEEN PROGRAM AT ATLAS, OUR YOUTH ART CENTER AND GALLERY.
